Eugene W. Landy was born November 6, 1933 in Perrineville, New Jersey. He and his wife of 57 years, Gloria, reside in Rumson, New Jersey. They have three sons: Samuel, an attorney-at-law who is President and CEO of UMH Properties, Inc; Michael, a Real Estate Executive who is President and CEO of Monmouth Real Estate Investment Corporation; and Richard, an Orthodox Rabbi. The Landys have eleven grandchildren.

Mr. Landy is a graduate of the United States Merchant Marine Academy, Class of 1955. He was a licensed Third Mate and Lt. J.G. in the U.S. Naval Reserve. He is also a graduate of Yale Law School, Class of 1958 and is Senior Partner in the law firm of Landy & Landy in Freehold, New Jersey. Mr. Landy is a member of the Monmouth County, New Jersey, and American Bar Associations.

Mr. Landy is one of the founders and is Chairman of the Board of Monmouth Real Estate Investment Corporation, a publicly-owned Real Estate Investment Trust (REIT).
